9. South Central Probation UPW Consultation 2024

Members are asked to consider and note:

Unpaid work (UPW), also known as 'community payback', is often added to community orders and suspended sentence orders in England and Wales. The main purpose of unpaid work is to provide punishment and reparation – with individuals working on projects that benefit the community.

There are also potential rehabilitative benefits, as unpaid work can develop life and vocational skills which reduce reoffending. We are keen to gather the views of local partners to understand how UPW could deliver more effectively for our communities and Members are asked to complete the survey previously circulated by e mail to Members.

10. Regulation 24 Notice of Independent Examination of the Hampshire Minerals and Waste Plan (HMWP) Partial Update.

The SDNPA works in partnership with Hampshire County Council, Portsmouth City Council, Southampton City Council and the New Forest National Park Authority on minerals and waste planning policy matters for the part of the South Downs National Park that falls within Hampshire. Collectively, the Authorities are known as the "Hampshire Authorities."

The Hampshire Authorities are working to produce a partial update to the Hampshire Minerals and Waste Plan (HMWP) which will guide minerals and waste decision making in the Plan Area (covering all their respective areas and those parts of the South Downs National Park which fall within Hampshire) up until 2040.

The Regulation 24 Notice of Independent Examination of the HMWP Partial Update is attached. The HMWP Partial Update and all other relevant documents have been compiled into an Examination Library which is available on the Hampshire County Council website here:

12. Plestor and Gracious Street flood

Councillor Ashcroft has requested this item on the agenda and has provided the following for consideration:

i) Plestor

Members are asked to discuss treatment to be taken to save the Oaktree as suggested in the tree report including long term protection of it. Suggestion removal of road and path with them being replaced by plastic tracking which allows rain to penetrate and grass to grow in creating a grass covered area that can be used for events like May Fair, carols, etc. Work party or sub committee to assertain costs etc to bring to council for decission.

ii) Gracious Street flooding

Members are asked to note that the culvert has been cleared but ditch and pipe to side of 9 acres lane does not carry enough water and larger diameter pipe needed and extended to up

to 100 meters. HCC Culvert across road needs to be cut to facilitate water to get in it, currently at 90degress to flow. Ditch in front of the Grange needs to be dug out urgently.

Members are therefore asked to consider the information above and agree a way forward. It has been suggested that a Working Party be set up from this meeting to move this matter forward including a couple of councillors and volunteers

13. Grounds Maintenance Contract Renewal

Members are asked to consider the quotes from the Locum Parish Clerk and receive an update on the situation with regard to the renewal of the Grounds Maintenance Contract.
